1 WHAT ARE EXPORT CONTROLS EXPORT CONTROLS ARE MEASURES IMPLEMENTED BY GOVERNMENTS TO RESTRICT THE EXPORT OF CERTAIN GOODS TECHNOLOGIES AND SERVICES DEEMED SENSITIVE OR POTENTIALLY HARMFUL THESE RESTRICTIONS CAN BE APPLIED TO MILITARY EQUIPMENT WEAPONS AMMUNITION AND RELATED TECHNOLOGIES DUALUSE GOODS ITEMS WITH BOTH CIVILIAN AND MILITARY APPLICATIONS THIS CAN INCLUDE TECHNOLOGIES LIKE LASERS COMPUTERS AND ADVANCED MATERIALS SENSITIVE SOFTWARE AND DATA CYBERSECURITY SOFTWARE ENCRYPTION ALGORITHMS AND CRITICAL INFRASTRUCTURE DATA STRATEGIC GOODS ITEMS CRUCIAL FOR NATIONAL SECURITY AND ECONOMIC DEVELOPMENT SUCH AS SEMICONDUCTORS AEROSPACE COMPONENTS AND TELECOMMUNICATIONS EQUIPMENT

3 KEY CONSIDERATIONS FOR COMPLIANCE BUSINESSES INVOLVED IN INTERNATIONAL TRADE MUST BE AWARE OF THE FOLLOWING KEY ASPECTS OF EXPORT CONTROL

APPLICABLE LAWS AND REGULATIONS EACH COUNTRY HAS ITS OWN SET OF EXPORT CONTROL LAWS AND REGULATIONS WHICH CAN BE INTRICATE AND CONSTANTLY EVOLVING

EXPORT LICENSING MANY COUNTRIES REQUIRE EXPORTERS TO OBTAIN A LICENSE BEFORE EXPORTING CERTAIN GOODS THIS PROCESS INVOLVES PROVIDING DETAILED INFORMATION ABOUT THE INTENDED RECIPIENT THE GOODS BEING EXPORTED AND THE ENDUSE OF THOSE GOODS

ENDUSE CONTROLS EXPORT CONTROLS OFTEN FOCUS ON THE INTENDED ENDUSE OF EXPORTED GOODS AND TECHNOLOGY EXPORTERS NEED TO ENSURE THAT THE GOODS WILL NOT BE USED FOR UNAUTHORIZED PURPOSES

SANCTIONS AND EMBARGOES GOVERNMENTS MAY IMPOSE SANCTIONS OR EMBARGOES ON SPECIFIC COUNTRIES OR INDIVIDUALS RESTRICTING TRADE AND FINANCIAL TRANSACTIONS

DUE DILIGENCE EXPORTERS MUST EXERCISE DUE DILIGENCE TO IDENTIFY AND MITIGATE POTENTIAL RISKS ASSOCIATED WITH THEIR EXPORTS THIS INCLUDES CONDUCTING THOROUGH RESEARCH ON THEIR CUSTOMERS AND THE INTENDED ENDUSE OF THE GOODS

RECORD KEEPING MAINTAINING ACCURATE AND DETAILED RECORDS OF ALL EXPORT TRANSACTIONS IS CRUCIAL FOR DEMONSTRATING COMPLIANCE WITH EXPORT CONTROL LAWS AND REGULATIONS
