pharmaceuticals constitute a relatively small share of the total health care expenditure in most developed economies and yet they play a critical role in the ongoing debate over how best to advance improve and afford health care despite this and perhaps because of this the

industry has had for many years an outsized claim to fame and controversy praise and criticisms and support and condemnation unfortunately many participants in the debate do not fully understand the complexities of the industry and its role in the overall health care system the analytical tools of economics provide a strong foundation for a better understanding of the dynamics of the pharmaceutical industry its contribution to health and health care and its dual and often conflicting priorities of affordability and innovation as well as the various private and public policy initiatives directed at the sector everyone is affected by big pharma and the products they produce at the drug store the physician s office in front of the television in everyday conversations drugs are a part of our lives society shapes our values toward drugs and drugs shape society the pill and minor tranquilizers are good examples and of course the way congress deliberates and big pharma responds has a huge impact on how drugs affect our lives this book is well researched on the subject of the pharmaceutical industry its struggles with government and its relationship to the consumer from the early twentieth century until the present the dynamic tension between the three participants government big pharma and the people is described and explained to lead to an understanding of the controversies that rage today the author describes how the government its many investigatory efforts and the ultimate legislative results affect the industry and the consequences of their activities are explored in light of their effects on other players including the patients and consumers who rely on both government and big pharma for their well being and who find sometimes unexpected consequences while giving special attention to the attitudes beliefs and misadventures of less than optimal drug use stakeholders are identified with physicians as a major focus as well as describing the significance of prescriptions as social objects and the processes by which physicians make choices on behalf of their patients the author ties it all together with how big pharma affects and is affected by each of these groups the author utilizes his 50 plus years experience as an academic practicing pharmacist and big pharma employee to describe the scope of the pharmaceutical industry and how it affects us on a daily basis concluding with an inside look at big pharma and how regulations marketing and the press have affected their business both good and bad

pharmaceutical medicine is very very big business the top ten players earned more than 200 billion in 2003 one drug pfizer s cholesterol pill lipitor had sales of more than 9 billion this kind of money buys an awful lot of friends among doctors and politicians most of those involved

in the formulation of public health policy seems happy with the present system the trouble is that the public is starting to have doubts there is a growing sense that the vast profits of drug companies and their control of the research agenda might not be that good for our health jacky law takes the reader on a journey through the pharmaceutical business and shows how the public is quite right to be concerned about conventional medicine as it has developed since the late 1970s she tells a story of spectacular regulatory failure phenomenally high prices betrayal of the public interest and a growing awareness among ordinary people that things could be very different sophisticated marketing and public relations not scientific excellence have helped corporations to preside unchallenged over matters of life and death it is time law argues for us to take responsibility for our health not as passive consumers of pharmaceutical medicine but as informed citizens

updated and revised edition throughout his distinguished legal career stephen sheller has relished the role of the underdog evincing a sharply honed sense of fair play and justice early in his career he represented black panthers in philadelphia when they were arrested on trumped up murder and conspiracy charges later he was in the vanguard of lawyers who took on the tobacco industry in the 1990s and he reprised that strategy a few years later in targeting big pharma for its harmful products and their deleterious effects on public health in big pharma big greed the inside story of one lawyer s battle to stem the flood of dangerous medicines and protect public health sheller tells a tale that is at once deeply personal but also with wide repercussions for the u s health care system and the hundreds of millions of americans whose lives literally depend on it decades of litigating against the pharmaceutical industry taught sheller one irreducible lesson in too many instances unneeded and at times dangerous drugs are foisted on the public without adequate warning as to risks all in the service of boosting industry profits all too often achieving block buster status for a patent protected medication becomes an end in itself as big pharma companies manipulate clinical trial data draft scholarly articles for friendly physicians often in their pay and market their drugs for uses that never had been approved by the federal food and drug administration this last practice proved to be something of an achilles heel for the industry in litigation that resulted in settlement and fines in the billions companies such as eli lilly acknowledged marketing drugs off label to a broad range of patients for whom the medications had never been approved sheller s litigation formed the basis for these settlements and the effort is ongoing he and other plaintiffs lawyers now are suing janssen pharmaceuticals for the adverse impacts of its drug risperdal a second generation anti psychotic that sheller and others allege is linked to the growth of female breast tissue in young boys and men already there have been several big jury verdicts against janssen with hundreds of more cases yet to be tried in the book sheller not only recounts his major litigation battles but also makes sweeping proposals for industry reform to restore regulatory credibility sheller proposes that responsibility for testing new medicines be taken away from the industry and given over to hospitals and other public entities partnering with government regulators pharmaceutical companies that betray the public trust would risk government initiated dissolution harsh medicine to be sure but sheller believes entirely appropriate to the underlying malady

this book explores the increasingly broad terrain of drugs in american society with an emphasis on politics it begins with the war on drugs

initiated by president richard nixon in the early 1970s and extends to the current day with the vast power of the pharmaceutical industry big pharma expansion of global criminal syndicates militarization of the drug war and struggles between states and federal government over the legalization of marijuana from the beginning the drug war produced increasing authoritarian tendencies in american politics visible not only in swollen national bureaucracies and burgeoning police functions but in the rise of the largest prison industrial complex in the world a surveillance state and the weakening of personal privacy and freedoms at the same time the legal drug system with some of the most profitable business operations anywhere has expanded to create a huge medical edifice affecting the delivery of health care development of modern psychology evolution of the treatment industry and many other areas of contemporary life including the world of sports and recreation although prohibitionism remains very much alive targeting a wide range of illicit drugs today it is the hundreds of widely marketed chemical substances sold by big pharma that result in some of the most serious health problems affecting society this book explores the long historical trajectory of both the war on drugs and the growth of big pharma focusing on social outcomes and political consequences in the us and beyond

the pharma companies relationship with the american people is characterized by price gouging and tax evasion little give and a lot of take while big pharma refuses to pay its due share of taxes in order to fill public coffers they are quite content to empty them over the last decade five of the pharma big 10 have received a total of 27 billion in government contracts in the united states big pharma creates and markets numerous life changing drugs and they profit handsomely from them and guess who foots a large portion of the expense for the development of these costly drugs it s just you and me taxpayer funded research from the national institutes of health nih contributed to the development of every one of the over 200 drugs brought to market over a recent seven year span even when taxpayers support the discoveries ordinary americans frequently do not have access to the medications they helped produce instead it is the pharma companies who profit other riches from the public cookie jar are snatched by big pharma excessive government monopolies that keep cheaper medications off the market tax breaks for all those annoying tv commercials and even sales and tax advantages from the charities they set up to assist us pay for their costly products how do they get away with everything it s simple money buys power drug companies spend more money influencing washington policymakers than any other sector and the drug industry counting the corporations their employees and their political action committees have donated almost 100 million to federal candidates over the past decade it s no surprise that new medications are being tested on some of the poorest individuals in certain nations without their knowledge taming big pharma can help to ensure that all companies contribute to society rather than prey on it

in transforming big pharma john ansell addresses critically how strategy works in the pharmaceutical industry the long standing dearth of new products has led to a growing shortfall in revenues ansell assesses the wide range of alternative strategies big pharma companies have been pursuing in recent years in attempting to overcome this he shows that there is sound evidence to expect the recent upturn in the number of new products reaching the market to go on to greater heights chapters assess the complex trends in attrition rates show how rife spectacular sales underestimation in the industry remains and explain how conventional wisdom on the chances of product profitability also seriously undersells the industry the surest route to transforming the prospects for big pharma ansell contends is to step up activity in acquiring and developing new products this is now realistic because as he shows the amount of intellectual property available is much greater than it was a

morals and the financial stability the job provided for her special needs son lisa made a decision that would change her life forever she reported the fraudulent practices of the company to the federal government for nearly a decade she led a double life feeding insider information to the department of justice while enduring the relentless demands of her company to sell their drug using illegal marketing tactics she faced constant fear of exposure knowing that the government offered her no protection if her secrets were revealed nonetheless lisa pressed on determined to hold questcor accountable for the laws they were breaking and the lives they were endangering this incredible true story offers a sobering look at the unscrupulous sales methods used by america s corrupt pharmaceutical industry spotlights the levers they pull to extract ludicrous profits from the sick and dying and is a page turning portrait of one woman s heroic fight against big pharma and a mother s struggle to protect her family

the history of medicinal drugs extends back to the earliest human civilizations when the search began for natural materialsplant animal or mineralthat might possess the power to cure alleviate or avert maladies or wounds the quest continues still conducted now by scientists and
